PROPOSITION TO ISSUE \$35,000,000  
SCHOOL BUILDING BONDS**

Shall the Board of Education of Princeton School District Number 115, Bureau and Putnam Counties, Illinois, acquire two sites; build and equip a school building on one of the acquired sites and improve said site; abate asbestos at and demolish the Lincoln Elementary and Logan Junior High School Buildings; alter, repair and equip the Douglas Elementary and Jefferson Elementary School Buildings; and issue bonds of said School District to the amount of \$35,000,000 for the purpose of paying the costs thereof?

**PUTNAM COUNTY  
PROPOSITION TO INCREASE THE CORPORATE  
TAX RATE**

Shall the current corporate tax rate of .37% be increased by .3% to a rate of .67%, which will be levied on the equalized assessed valuation of the taxable property in Putnam County, State of Illinois?

(1) Corporate tax rate is commonly referred to as the general fund and is used for the goods and services provided to the county.

(2) The approximate amount of taxes currently collected with the corporate rate of .37 is \$553,358.00, which is dedicated to the general fund. If approved, the approximate amount of taxes to be collected with the corporate rate of .67 is \$1,041,336.00.

(3) For the 2019 levy year the approximate amount of additional taxes against property containing a single-family residence having a fair market value (at the time of the referendum) of \$100,000.00 with the homestead exemption applied, is estimated to increase by \$82.00. A single-family residence with a fair market value (at the time of referendum) of \$100,000.00 with no exemptions applied is estimated to increase by \$100.00.
